Skip-a-Pay is available for auto and personal loans only. Skip-a-pay cannot be implemented on loans paid ACH from another financial institution. One loan per applicant only. Loans that do not qualify include Real Estate, VISA, Overdraft Protection, and Share Secured Loans. Member must be current on all loans over the previous 12 months to qualify. Loan must have at least 6 consecutive months of payment history to be eligible. There is a \$15 processing fee for this service. **Application must be submitted 2 weeks prior to the payment you are applying to skip.**
